Investment criteria for Personal Account only (not available for UK residents)

Only shares listed and quoted on a recognised stock exchange shall be recommended. Only bonds that are in line with RL360° Services's current accepted ratings shall be recommended. Only currency deposits in major freely convertible currencies held with authorised institutions shall be recommended. Only authorised collective investment schemes which are FCA recognised, or equivalent shall be recommended.

No direct investment is allowed in derivatives or in tangible commodities.

Additional conditions

All assets purchased and dealings must be made and rendered in the name of RL360° Services.

The investment adviser hereby acknowledges and agrees to adhere to the applicant/bondholder's selected investment objectives and levels of risk, as set out in Section 1. The investment adviser acknowledges that RL360° Services accepts no responsibility for ensuring that the investment objectives and risk levels are followed by the investment adviser, and that RL360° Services will not monitor compliance by the investment adviser with the applicant/bondholders stated objectives and stated risk levels.

The investment adviser shall ensure that the investment policy and transactions recommended by him will not lead to the Account/Fund being more than 100% invested, nor shall it exceed any agreed 'overdraft' limit and that appropriate liquidity in the Account/Fund is maintained in order to meet charges, regular withdrawals and any other liabilities incurred on behalf of the Global Investor/Portfolio Bond.

Notwithstanding any other provision in this section, RL360° Services in its absolute discretion retains the right to reject or accept recommendations given by the investment adviser.

This appointment ('the Agreement') may be terminated by either party upon written notice. RL360° Services shall be entitled to terminate this Agreement without specifying a reason.

In the event of death, bankruptcy or insolvency of the investment adviser or upon the investment adviser's wilful misconduct or negligent act or omission or if, being a company, it passes a resolution to wind-up the company (other than for the purpose of reconstruction or amalgamation) or where a liquidator or receiver of its assets is appointed, or an administration order is made in respect thereof, or if it becomes illegal for the investment adviser to continue to act in this capacity, this Agreement shall terminate forthwith, without notice.

This Agreement is not assignable and investment recommendations will only be accepted from the appointed investment adviser.

This Agreement shall be governed and construed in accordance with the laws of the Isle of Man and the Manx courts shall have exclusive jurisdiction in relation to any dispute arising out of this Agreement.

I/We agree to supply RL360° Services with a list of the names and specimen signatures of all persons authorised to give investment recommendations in respect of the Account/Fund as per Section 3 and will procure that the obligation to notify RL360° Services, contained therein, will be complied with.
